**DATED : 1<sup>st</sup> October, 2014**

**Subject:- Creation of new Service Tax Commissionerate at Noida under Customs, Central Excise & Service Tax, Meerut Zone, Meerut and allocation of jurisdiction thereof.**

In pursuance of Ministry's Notification No.20/2014-Service Tax dated 16<sup>th</sup> September, 2014, (Table-1 & Table-3) a new Service Tax Commissionerate has been created within the jurisdiction of Customs, Central Excise, & Service Tax, Meerut Zone, Meerut.

2. The new Service Tax Commissionerate will start functioning with effect from the **15<sup>th</sup> October, 2014.**

3. The Principal Commissioner of Service Tax, Noida will head the said Commissionerate, which will have the jurisdiction over the Districts of Gautam Budh Nagar (**except the area falling under Central Excise & Service Tax, Commissionerate, Ghaziabad**) and Bulandshahr in the State of Uttar Pradesh.

4. The jurisdiction of the subordinate formations i.e. 'Divisions' of newly created Service Tax Commissionerate is divided into 5 Service Tax Divisions and will be as per following details:-
